

002.01	To confirm the minutes of the first meeting of Academic Council held on 30th July 2019		
	-Dr. S. K. Kulkarni enquired if there were any suggestions made by any member after the receipt of the minutes of the first meeting. Prof. Evans Coutinho mentioned that there were no objections/ suggestions received from the members. Hence, on the behest of Dr. Kulkarni, the minutes of the first meeting were formally confirmed.  -Dr. Kulkarni asked for action taken report on the points discussed in the first AC meeting. In response, Prof. Coutinho referred to the list of examiners collated and tabled by Prof. Krishna Iyer.		
002.02	To consider rules for recognizing teachers as Guides for the M. Pharm and PhD		
002,02	-Prof. Coutinho highlighted the fact that due to retirement of a considerable number of the teaching staff in different departments, there is a vacuum for research guides in the college. Consequently, the existing approved guides are overburden with guiding large number of post graduate students. Hence, to ensure a conducive research environment, a research policy for recognition of research guides has been drafted and tabled for consideration in this meeting.  -In response, Dr. S. K. Kulkarni enquired about the possibility of permitting the established faculty members, Dr. Mala Menon & Dr. M. Nagarsenkar to guide students as this is permitted under UGC. However, Prof. Coutinho clarified that both Dr. Mala Menon & Dr. M. Nagarsenkar have been appointed as Adjunct faculty and Professor Emeritus by BCP and these are not university approved appointments. In this context, Dr. Kulkarni suggested that the college should seek clarity on the rules and regulations associated with the position of Professor Emeritus/Adjunct faculty from Mumbai University for leveraging their rich research capabilities for the benefit of the institution.  -On perusing the rules and regulations for the appointment of research guides, Dr. Kulkarni suggested broadening the ambit of the term 'scientist' as stated in (2. ii.) to Kulkarni suggested broadening the ambit of the term 'scientist' as stated in (2. ii.) to include the Ramalingaswamy & Ramanujam fellows as well as DST inspire fellows, include the Ramalingaswamy & Ramanujam fellows as well as DST inspire fellows, these can be appointed as Associate Professors. This suggestion was concurred by Prof. Vavia who mentioned that Institute of Chemical Technology (ICT) boasts of numerous such fellows as ICT faculty. Further, Prof. Vavia emphasized the value addition brought to the institutional research environment by research funding accorded to such prestigious fellows. from the date of joining the institute. However, for guiding interdisciplinary research, it is recommended the faculty initiates research as a co-guide or after 3 years of service.

- Dr. Kulkarni also recommended that vacancies in teaching should be advertised in National Newspapers or on the college website, mentioning that the institute welcomes researchers with the aforesaid fellowship. Dr. Mahajan also suggested that the LinkedIn platform is also a good mode to address the needs of the institute in the long run. Prof. Vavia also recommended that the college should encourage alumni residing abroad to apply for such fellowships that could be tenured at BCP.


-It was commonly noted that faculty members who have joined the college with a Master's degree are desirous to pursue their PhD. degree. Such faculty members should normally not be allowed to guide post graduate students, as this could be a potential conflict of interest and may lead to malpractices. To this effect, clause 1 should be accordingly rephrased to include new recommendation. Dr. Kulkarni strongly recommended that each faculty member in the institution should be encouraged and insisted that they should be allowed to guide research students, as this is the new requirement of teachers as defined by the UGC.

- Dr. Ujwala Shinde raised a query about the acceptability of these new rules citing Dr. Harita's ineligibility for qualifying as a research guide by University of Mumbai. In this context, Prof. Vavia enquired if the approval in the Academic Council will have any credibility. In response, Prof. Coutinho clarified the as per autonomous rules and regulations, University of Mumbai only governs the policy for PhD. guides. Hence, the rules once approved by the academic council can be adopted as the research policy of the institution. As a cautionary note, Prof. Vavia recommended that the Rules regarding recognition of guides as put up in the Academic Council should be sent to the University of Mumbai. Dr. Kulkarni made a strong recommendation that as an autonomous institute it is essential to have flexibility to promote strong research. Prof. Coutinho mentioned that he has heard that the other autonomous colleges are approaching the University to take the PhD program also under the umbrella of governing of Autonomous colleges as enshrined in the rules and regulations of UGC regarding Autonomous Status. To consider allocating seats for Industry Personnel desirous of pursing the PhD program in

Bombay College of Pharmacy. -Prof. Coutinho mentioned that the college has permission to admit 35 students for the doctoral degree. In view of the large number of requests received from personnel from the industry/academia who are desirous of pursing the PhD program in BCP, the college intends to extend this opportunity to industry personnel too. In this context, Prof. Vavia mentioned that at ICT, teachers from colleges affiliated to Mumbai University having 5 years' experience or industry personnel with minimum 2 years' experience, are allowed to enroll for the PhD program in ICT and a similar criteria

could be adopted by BCP. Candidates under this category should be GPAT qualified or should have passed the PET exam held by the University of Mumbai. In case of an industry sponsoring a candidate for the PhD program, this facility should be extended only to those industries that are DSIR recognized. In case of teachers from affiliated colleges, BCP should send a team of experts to that college to ensure that the sponsoring college has all facilities and amenities to conduct research. Candidates admitted under this category, beside the guiding teacher at BCP, should choose a coguide from the industry who will monitor the day-to-day research work being done at the industry. Also the candidates should complete the mandatory course work as prescribed by the University of Mumbai and after registration should work for at least 6 months in the laboratory of the research supervisor at BCP.

-Dr. Kulkarni also mentioned that as per UGC guidelines the laboratory where the research is being conducted has to be approved by Bombay College of Pharmacy (BCP) and proper legal documents should be drafted.-Mr. Nitin Maniar mentioned that BCPshould draft and adopt unique policy which will ensure the right candidates enrolled. Dr. Mahajan added that in his past experience at Piramal, they had an arrangement with one of the institutes who agreed to permit 3 industry employees to enroll for doctoral course only after successful passing of the entrance exam.

-Prof. P. R. Vavia mentioned that ICT has an institute-industry tie-up wherein industry has to pay ₹ 5.0 lakh as registration fee for liaison for 4 years along with a contingency grant of ₹ 40,000. The tie-up is revised after every 4 years. Dr. N. Sivaprasad mentioned that in one of the institutes in Mangalore there is similar industry-academia liason for enrolling PhD students.

-As a common consensus, it was agreed to make the enrollment of personnel from industry/academia for the PhD program dynamic i.e. to invite applications from PhD research scholars followed by personnel from the industry/academia, and admission to be made so as to ensure that all vacancies at a given point in time are filled. This will help to increase the doctorate output of the institute which eventually influences NIRF

-Prof. Coutinho said that the college will try to seek recognition from the University for the college and faculty for science programs in addition to technology, as the college sees great potential in initiating the M. Sc. programs in Analytical Chemistry. This suggestion was conceded by Dr. Shirsat who mentioned that the training programs recently conducted by her received response predominantly from M. Sc students. R. Vavia mentioned that it was worthwhile to start programmes in M.Sc ( Analytical Chemistry) as the institutes majoring in basic science generally undertake pharmaceutical analysis for the students dissertation. In continuation to this, Dr. Kulkarni suggested to request Dr. Anuradha Majumdar, Dean, Faculty of Science& Technology to make an application for recognition under science category

	-Dr. Kulkarni mentioned that considering autonomy, the evaluation pattern should be revamped and open defense should be adopted. There should be a panel of experts preferably from Mumbai and provisions should be made to appoint a replacement in case a referee in unable to attend the viva-voce examination.		
	-Prof. Vavia also mentioned that rules should be framed for conduct of the viva-voce exam and the Research Recognition committee should be constituted to define the constitution of the examiners panel. Also for the viva-voce exam a Chairman should be appointed who will preside over the committee.		
	It was suggested that the list of the referees should first be approved in the BOS and then routed to the Academic council for approval.

	-Dr. Kulkarni mentioned that many colleges in the country are facing serious issues in running the PCI syllabus. He suggested that there should be flexibility for defining the syllabus for autonomous colleges and BCP should make efforts to address this issue with UGC.



#### Appendix 1

#### Rules for recognition of PG teachers of Bombay College of Pharmacy

- 1. A teacher who joins the services of Bombay College of Pharmacy on Posts approved by the University of Mumbai/Directorate of Technical Education can be recognized as a teacher for post graduate teaching and also as a recognized guide if s/he has been selected as a teacher by the Selection Committee duly constituted by the University of Mumbai.
- 2. A teacher will be recognized as a guide for the PhD Degree if
  - S/he has obtained a PhD or equivalent degree from a university in India recognized by the UGC or from a university abroad that is known to impart quality education in pharmacy or in allied sciences. In case of the latter, if in doubt, the matter may be discussed in the BOS and/or in the Academic Council of BCP and
  - S/he has a minimum of three years of teaching as an approved teacher of Bombay College of ii. Pharmacy or from a department/college of any other university in India that is recognized by the UGC or from a university abroad that is known to impart quality education in pharmacy or in allied sciences (in case of the latter, if in doubt the matter may be discussed in the BOS and/or in the Academic Council of BCP) and has guided at least 5 students for the M. Pharm degree or a Master's degree in an allied field and

OR

If a teacher does not have three years of teaching experience but has worked for a minimum of 5 years as a Scientist in a National Laboratory or in an Academic Research Institute or in a R&D laboratory in the industry or is a Ramalingaswamy/Ramanujan/DST Inspire fellow, then s/he may be recognized as research guide for the PhD degree and

- S/he should have published minimum five research papers (reviews or original research) in journals that have a Scopus Impact factor/or journals that have been approved and recognized by iii.
- A teacher will be recognized as a research guide for the PhD degree in the subject in which s/he has secured his/her PhD. degree. A request to be recognized as a research guide in a subject/stream iv. other than the one in which s/he has obtained his/her PhD may be granted by the Academic Council of BCP based on his/her teaching and research experience and on published research papers and patents, but will be automatically granted if s/he has been approved as a teacher by the University of Mumbai or from a University in India recognized by UGC in that subject/stream. In the same context, a teacher who has already been approved as a research guide by the University of Mumbai or from a University in India recognized by the UGC in various subjects/streams can continue as a guide for the PhD degree in these very same subjects/streams.
- 3. A teacher will be recognized as a guide for the M. Pharm. degree (partly by papers and partly by thesis) if



- A teacher will be recognized as a research guide for the M. Pharm. degree in the subject in which iii. he has secured his/her M. Pharm. degree. A request to be recognized as a research guide in a subject/stream other than the one in which s/he has obtained his/her M. Pharm. degree may be granted by the Academic Council of BCP based on his/her teaching and research experience and on published research papers and patents but will be automatically granted if s/he has been approved as a teacher by the University of Mumbai or from a university in India recognized by UGC in that subject/stream. In the same context, a teacher who has already been approved as a research guide by the University of Mumbai or from a University in India recognized by the UGC in various subjects/streams can continue as a guide for the M. Pharm. degree in these very same subjects/streams.
